ORDER

Now on this _____ day of _____, 20____, it being a regular business day of the Term of the County Commission of Camden County, Missouri, the County Commission is presented with an Affidavit of a Taxpayer and/or the Assessor advising the County Commission of an erroneously assessment or of a mistaken or erroneous payment of property taxes. A copy of that Affidavit is attached to the within Order and makes reference to the following described property:

1. The Camden County Commission determines that the taxpayer in question did not attend the County Board of Equalization for the purpose of correcting errors or defects or mistakes claimed and has presented good cause for not attending said County Board of Equalization meetings.

The Camden County Commission further determines that there was an erroneous assessment for the property in question and reflected on the attached Affidavit and that the erroneous assessment should be changed as follows:

The County Clerk is hereby directed to correct the erroneous assessment on the County Tax Book and to certify the change and correction to the Director of Revenue, if appropriate, and to the County Assessor and County Collector.

OR

2. That an Affidavit of Taxpayer is attached hereto requesting a refund of property taxes because the property tax has been mistakenly or erroneously levied and paid. The property tax asserted to be mistakenly or erroneously levied and paid is as follows:

The County Collector believes that said property tax was mistakenly or erroneously levied and paid and recommends that it be refunded. The County Commission will make funds available to

the Collector which are necessary to make the refund or in the alternative, the County Collector may give the taxpayer credit for the mistaken or erroneously paid taxes on future taxes.

If tax is to be abated it is to be distributed as follows:
