

**COUNTY COMMISSION RECORD, CAMDEN COUNTY, MISSOURI**  
**WEDNESDAY 7/25/2018**

The Camden County Commission met with Presiding Commissioner Greg Hasty, District #1 Commissioner Beverly Thomas, and District #2 Commissioner Don Williams.

**Meeting Agenda**

Commissioner Thomas made a motion to approve today's agenda as posted. Commissioner Williams seconded the motion. The motion passed by vote: Commissioner Thomas (Yes) Commissioner Williams (Yes). Session opened at 10:00 A.M.

**Prior Minutes**

Commissioner Williams made a motion to approve July 12, 2018 minutes. Commissioner Thomas seconded the motion. The motion passed by vote Commissioner Thomas (Yes), Commissioner Williams (Yes).

**New Business**

**BID OPENING - COLLECTOR-** Commissioner Hasty asked how many bids have been submitted. Only one bid was received and was from Edward Price. Commissioner Thomas made a motion to table the bid pending the review from the County Collector. Commissioner Williams seconded the motion. The motion passed by vote: Commissioner Thomas (Yes), Commissioner Williams (Yes).

**RESOLUTION –SHADOW OAKS-** Commissioner Thomas stated this is the resolution for the NID done in 2016 for Shadow Oaks. The county attorney has prepared this resolution as required by law to collect the taxes for Shadow Oaks and remit those taxes to the city of Camdenton. Commissioner Williams made a motion to approve the resolution as prepared by county attorney. Commissioner Thomas seconded the motion. The motion passed by vote: Commissioner Thomas (Yes), Commissioner Williams (Yes).

**HBRD - QUIT CLAIM DEED-** Commissioner Thomas stated the Lodge of Four Seasons originally did this TDD. When the Lodge of Four Seasons changed hands the road district requested to take over the roads, in order for the road district to take over the roads the county has to own them. As requested the private roads were then quit claimed to the county. Since the Lodge has taken it back over, they have requested that they take over the roads again and make them private. They are asking to have the same property quit claimed back to them. The Horseshoe Bend Road District will no longer maintain them with this. Commissioner Thomas made a motion to approve the quit claim deed from the county back to the Lodge of Four Seasons. Commissioner Williams seconded the motion. The motion passed by vote: Commissioner Thomas (Yes), Commissioner Williams (Yes).

**Other Business & Meeting- Wave Security-** Commissioner Thomas recently went to a meeting at the sheriff's office and she was present for a presentation for Wave Security. Commissioner Thomas believes that this is will be beneficial to the county and has asked to place this on the agenda for next week.

**Adjourn:** With no further official business on the agenda: Commissioner Williams made a motion to adjourn to any unofficial business that may develop during the day. Commissioner Thomas seconded the motion. The motion passed by vote: Commissioner Williams (Yes) and Commissioner Thomas (Yes). Session closed at 10:25 A.M.
