The jobsite is accessed as follows: North State Hwy 5 to State Hwy 7 to State Road J to Nonsuch Road to Silent Springs Road. North State Hwy 5, State Hwy 7, State Road J are maintained by MODOT. Nonsush Road is a gravel road and Silent Springs Road is a private road. No paved roads maintained by the Camden County Road and Bridge

Department will be impacted by this construction. The Road and Bridge Department recommends that the road impact fee be waived for the attached construction permit.
