AGREEMENT FOR LAW ENFORCEMENT SERVICES BETWEEN
THE FOUR SEASONS LAKESTATES PROPERTY OWNERS ASSOCIATION, INC. AND THE
CAMDEN COUNTY SHERIFF'S OFFICE
(2020 SECURITY YEAR)

THIS AGREEMENT is made and entered into by and between the Four Seasons Lakesites Property Owners Association, Inc. (herein referred to as "the POA") a Missouri Non-Profit Corporation, the CAMDEN COUNTY MISSOURI SHERIFF'S OFFICE, (hereinafter referred to as "the Sheriff") a political subdivision of the state of Missouri, and the CAMDEN COUNTY COMMISSION, (hereinafter referred to as "the Commission"), a political subdivision of the state of Missouri.

WITNESSES:

WHEREAS, it is the joint desire of the POA, the Sheriff and the Commission being the governing bodies thereof to enter into an agreement granting the Sheriff and all duly commissioned deputies of the Sheriff the authority to provide police protection to the POA.

NOW THEREFORE it is agreed as follows:

ARTICLE I

1. The Sheriff shall provide additional Law Enforcement Services for POA's property owners, homes and other establishments in the POA, including but not limited to, answering calls for protective services from residents and members of the POA, all within the "Scope and Services" set forth in Exhibit A, attached hereto and made a part hereof. Such Law Enforcement Services shall be conducted by commissioned regular and reserve deputies. The Sheriff shall furnish all necessary supervision, equipment, communication, facilities, vehicles and supplies necessary to provide services and protection contemplated under the terms of this Agreement.

2. The Sheriff shall have complete and sole authority and discretion with respect to the administration and delivery of the Law Enforcement services contemplated hereto, the standard of performance of all deputy sheriffs, and other such matters incident to the performance of this agreement.

3. The Sheriff shall provide the POA with the required accountability reports, a summary of which are set forth in Exhibit B, attached hereto and made a part hereof.
