Agreement for Road Maintenance

The Miller County Commission agrees to perform snow removal and apply salt and cinders on Black Road in Camden County, and to grade and maintain the Miller County end of Ridge Crest Rd. and Kinderhook Rd; which is approximately 5 miles. In return Camden County agrees to grade and haul rock on the Camden County end of Swinging Bridges Rd; a distance of approximately 5.5 miles.

Each County will get approval from the other County before any material is purchased, and only routine maintenance will be performed. Any additional work or improvements will be done by the home County.
