The Camden County Commission met with Presiding Commissioner Ike Skelton, First District Commissioner James Gohagan, and Second District Commissioner Don Williams.

Meeting Agenda

Commissioner Gohagan made a motion to approve today's agenda. Commissioner Williams seconded the motion. The motion passed by vote: Commissioner Gohagan (aye) and Commissioner Williams (aye). Session opened at 10:02 A.M.

Prior Minutes

Commissioner Williams made a motion to approve February 15, 2024 Meeting Minutes. Commissioner Gohagan seconded the motion. The motion passed by vote: Commissioner Williams (aye) and Commissioner Gohagan (aye). Commissioner Williams made a motion to approve February 16, 2024 Meeting Minutes. Commissioner Gohagan seconded the motion. The motion passed by vote: Commissioner Williams (aye) and Commissioner Gohagan (aye).

New Business

Bid Opening- 24220 Human Trafficking Training- There was only one bid received and it is from the Human Trafficking Training Center who was contacted by Tena Riley. Commissioner Williams made a motion to accept this bid. Commissioner Gohagan seconded the motion. The motion passed by vote: Commissioner Williams (aye) and Commissioner Gohagan (aye).

CDBG Closeout- Barbara Bohley- Barbara Bohley was present to discuss the current standing of the Macks Creek Public Water Supply and the grant that was

used to make some upgrades to the well and water tank along with other improvements for the community. There were no votes taken on this agenda item.

Public Admin.- Requesting Additional Space for Operations- Tom Gorsline, Public Administrator for Camden County, was present to address the Commission regarding the need for more office space. He claims there are issues with privacy, the shared wall with the PA's office is very thin and can be heard through, and he has had to convert his waiting area to a fourth office for another employee. Their caseload is growing and he needs to expand. Commissioner Gohagan asked if he had any ideas on how he could expand his office and Gorsline stated that the Lighthouse doctor office by Butts Barbershop is for sale and could possibly be a good investment for the county. There were no motions made on this agenda item.

Sheriff- 240125-A Uniform Bid- Discuss Acceptance of Third Bid- A third bid was received on the day of bid opening (January 25, 2024) in the Purchasing Department at 9:52 A.M., but the bid was not present for the Commission meeting that morning at 10:00 A.M. The Sheriff's Office employees stated that they use this company more than the other two that were originally accepted on the bid opening date. The Commission conversed with the County Counselor in regard to any statutes that may be interrupted if this third bid is accepted. There is no belief that there will be an issue with accepting this bid with the other two since it was received in the building on the day of bid opening before 10:00 A.M. Commissioner Williams made a motion to accept this bid. Commissioner Gohagan seconded the motion. The motion passed by vote: Commissioner Williams (aye) and Commissioner Gohagan (aye).

Verizon Funding Authorization Form- Allows County to Purchase Under GSA Schedule- This is a contract that is signed every two years. Commissioner Gohagan made a motion to approve the GSA contract with Verizon. Commissioner Williams seconded the motion. The motion passed by vote: Commissioner Gohagan (aye) and Commissioner Williams (aye).

NovaTime Contract- Upgrades- The Commissioners agreed they needed time to look over the NovaTime contract that is up for renewal for another 5 years of service. Commissioner Williams made a motion to table this item on the agenda until Thursday, February 22, 2024. Commissioner Gohagan seconded the motion. The motion passed by vote: Commissioner Williams (aye) and Commissioner Gohagan (aye).

Adjourn: With no further official business on the agenda, Commissioner Williams made a motion to adjourn to any unofficial business that may develop during the day. Commissioner Gohagan seconded the motion. The motion passed by vote: Commissioner Williams (Yes) and Commissioner Gohagan (Yes). Session closed at 10:21 A.M.
