The Camden County Commission met with Presiding Commissioner Ike Skelton, District #1 Commissioner James Gohagan, and District #2 Commissioner Don Williams was absent.

Meeting Agenda

Commissioner Gohagan made a motion to amend today's agenda to add the appointment of the Camden County Health Department Director under Old Business. Commissioner Skelton seconded the motion. Accounting Policy and Procedures- Partial Reinstatement- The Auditor, Jimmy Laughlin, requested that the policy be reinstated in full with the understanding that the Commission still plans to review and change the policy. Commissioner Gohagan denied his request. The Auditor then notified the Commission that he is a mandated reporter, and if the county does not have an Accounting Policy and Procedures manual, he is required to notify the state. Commissioner Skelton asked Commissioner Gohagan if he would entertain a motion to reinstate the entire policy with the intention of reviewing the entire policy and have a rewritten draft by the end of March. Commissioner Gohagan states that he is only willing to reinstate pages 26-49 which outline policies and procedures directly related to Federal Grants, and pages 19-20 regarding Fixed Assets with the understanding that every page will be reviewed and a re-write will be created. Commissioner Gohagan made a motion to reinstate pages 26-49 and 19-20 of the Accounting Policies and Procedures Manual. Commissioner Skelton seconded the motion. The motion passed by vote: Commissioner Gohagan (Yes) and Commissioner Skelton (Yes).

Show-Me Checkbook- The Show-Me Checkbook is the Missouri State Treasurer's financial data transparency portal, and Camden County Treasurer, Kendra Hicks, recommends that Camden County should consider using the portal so that citizens of the county would be able to view every check that is written from the county. The information provided would be who the check was written to, the date, and the amount of the check. There is also a section where additional information can be added about the funds. There were no votes taken on this matter.
