

# COUNTY COMMISSION RECORD, CAMDEN COUNTY, MISSOURI

**Monday 03/13/2023**

The Camden County Commission met with Presiding Commissioner Ike Skelton, District #1 Commissioner James Gohagan, and District #2 Commissioner Don Williams was absent.

## **Meeting Agenda**

Commissioner Gohagan made a motion to approve today's agenda. Commissioner Skelton seconded the motion. The motion passed by vote: Commissioner Gohagan (Yes) and Commissioner Skelton (Yes). Session opened at 10:00 A.M.

## **Prior Minutes**

Commissioner Gohagan made a motion to accept the March 9, 2023 minutes. Commissioner Skelton seconded the motion. The motion passed by vote: Commissioner Gohagan (Yes) and Commissioner Skelton (Yes).

## **Unofficial Business**

**Issues/Communications brought to the Commission-** The Commission met to discuss many topics of issues/concerns brought forth to the Commission: CCAYEC wants to bring back a Camden County Fair, One Source owned by Marty Ostronic is applying for a mining permit to stay within DNR guidelines while working on his property in Linn Creek, the county server will need replaced by end of 2023, our current IT company (Huber), the marijuana tax language, and the tentative move-in date for many offices within the courthouse. There were no decisions or motions were made on these matters.

**Show-Me Checkbook-** Commissioner Gohagan stated that he likes the idea of using the State's website to upload any checks written from the county with the date, dollar amount, the payee, and what the funds are being spent on as well as having that same information uploaded to our county website as well to create

more transparency. Commissioner Gohagan also stated that he reached out to the Auditor to discuss this matter, and the Auditor would like for this information to be found on the county page only. There were no decisions or motions made on this matter.

**PTO-** Commissioner Gohagan received word from the Auditor that our accounting software BS&A has a new PTO system in place and ready to use starting January of 2024. The Commission will meet with elected officials at a later date to discuss this issue once more and vote on the way PTO will be accrued and used from January 2024 on. No decisions or motions were made on this matter.

**Floodplain Map-** Commissioner Skelton attended a meeting last week regarding Flood Risk Review #1 where he learned of a floodplain website that citizens can visit to view and submit information regarding current floodplains: <http://bit.ly/MOSEMAOutreach>. Commissioner Skelton also encouraged all individuals to check this out and provide information if they see something that they believe may need updating or is incorrect. There were no decisions or motions made on this matter.

**Energy Loan Program-** The only statement made regarding this matter was that none of our offices within the County meet the requirements. No decisions or motions were made on this matter.

**Adjourn:** With no further official business on the agenda, Commissioner Gohagan made a motion to adjourn to any unofficial business that may develop during the day. Commissioner Skelton seconded the motion. The motion passed by vote: Commissioner Gohagan (Yes) and Commissioner Skelton (Yes). Session closed at 11:35 A.M.
