County Health Fund Discussion- Camden County Treasurer, Kendra Hicks, brought to the Commission's attention that the fund for employee health care had very minimal funds left in it recently and requested a discussion about a solution. Jeremy Billington, the county's insurance broker, was present to discuss possible reasons for why this could be occurring. The county has not increased the amount they fund for their employees' health care since they started using this insurance plan nine years ago. The county is now seeing the effects of inflation and rising costs in health care. Camden County Auditor and Treasurer looked into the health care fund some time back and thought that if the county increased the amount (currently paying \$604/employee/year) by \$50-\$100, the health care fund would suffice on its own and wouldn't be dimished like so. The Commission advised the Auditor to draft some budget amendments for increasing the employee benefit paid by the county and present them at an upcoming meeting to be voted on. There were no motions made on this agenda item.

Other Business

Letter from City of Camdenton about Easement- Commissioner Gohagan received a letter from the City of Camdenton Administrator stating they're annexing down to the Ozark Amphitheatre. The City of Camdenton is requesting Camden County grant access, ingress, and egress to the City of Camdenton to install water and sewer services, including future maintenance, along the county right-of-way. The county attorney is going to look into this issue before granting any requests. No motions were made.

Update From Visit to Three Brothers Meat Co.- Commissioners Skelton and Gohagan visited Three Brothers Meat Co. this morning at 10:00 A.M. upon request of the owners because inspectors from DNR were scheduled to be there. Commissioner Skelton reported what he learned while at Three Brothers Meat Co. There were no motions made on this agenda item.
