The Camden County Commission met with Presiding Commissioner Ike Skelton, First District Commissioner James Gohagan, and Second District Commissioner Don Williams was absent.

**City of Sunrise Beach Request to Pave Trails End Road-** There was brief discussion about paving Trails End Road in Sunrise Beach. There were no motions made on this agenda item.

**Discussion of Approach to Handling Transportation Dropping Off Illegal Immigrants within Camden County-** Sam Henley with Camden County Emergency

Management Agency presented a rough copy of EMA's intentions should they be alerted that undocumented immigrants are being dropped off within county limits. She states that they are mandated to provide the basic necessities but have no intention of housing them long-term. Commissioner Skelton voiced his concerns and how he feels the county should respond to a situation like this. There were several people in attendance whom volunteered to be on a committee with EMA to come up with a more organized strategy. There were no motions made on this agenda item.
