

COUNTY COMMISSION RECORD, CAMDEN COUNTY, MISSOURI

Thursday 03/30/2023

The Camden County Commission met with Presiding Commissioner Ike Skelton, District #1 Commissioner James Gohagan, and District #2 Commissioner Don Williams arrived at 10:20 A.M.

Meeting Agenda

Commissioner Gohagan made a motion to amend today's agenda to rearrange the items as follows: public comment, Everblu Towner under Old Business, and finally, Verizon Fleet Management. Commissioner Skelton seconded the motion. The motion passed by vote: Commissioner Gohagan (Yes) and Commissioner Skelton (Yes). Session opened at 10:00 A.M.

Prior Minutes

Commissioner Gohagan made a motion to accept the March 28, 2023 minutes. Commissioner Skelton seconded the motion. The motion passed by vote: Commissioner Gohagan (Yes) and Commissioner Skelton (Yes).

Minutes from 03/29/2023 were not completed. No action was taken.

New Business

Public Comment- The Commission met with citizens Debbie Wright and Janelle Bednara, both from Montreal, MO, to discuss road conditions of some roads in the Montreal area. Janelle expressed her gratitude toward the road and bridge department, but requested that the commission get involved and look at the roads for themselves. She would like the county to come up with a strategy to fix the road versus putting a band-aid on it until the next time it needs repaired. Debbie Wright presented multiple pictures to the commission showing the state of Jeffries Road in Montreal including the washed out slab. The commission explained to both citizens that there are many roads in the same, close to, or

worse condition and each issue has to be prioritized in order of urgency and cost to the county, but also that they want to address these roads as fast as they can. There were no decisions or motions made on these matters.

Everblu Towner- Sheriff Phone System- OLD BUSINESS- There were two employees present from Everblu Towner to discuss a contract that they presented to the Sheriff's office previously. Commissioner Gohagan tabled this item at the 03-28-2023 meeting due to a clause regarding Google Analytics. Today, Towner presented a new contract excluding Google Analytics as the commission requested. Commissioner Gohagan made a motion to approve the new Towner Communications Systems, Inc contract for the Sheriff's Office. Commissioner Williams seconded the motion. The motion passed by vote: Commissioner Gohagan (Yes) and Commissioner Williams (Yes). There was a new contract presented to the commission for the courthouse phone system. Commissioner Gohagan made a motion to table this contract. Commissioner Williams seconded the motion. The motion passed by vote: Commissioner Gohagan (Yes) and Commissioner Williams (Yes).

Verizon Fleet Management- The commission met with employees of Verizon to discuss their fleet management system. They've been working closely with Captain Chad Bailey to make sure that their services provide everything the sheriff's office would need for tracking deputies around the county for safety purposes, speeds of the vehicles, maintenance needs and much more. The commission was thinking this same program would be beneficial to the road and bridge department for equipment such as tractors, graders, and dump trucks. Commissioner Gohagan looked through the contract at the meeting and verified that the county would have assistance in setting up the equipment in each vehicle and training to learn the mobile application and computer website. Commissioner Gohagan asked that Verizon provide the commission with three quotes for the county: one with ALL county vehicles utilizing their services, one with the amount of vehicles Sheriff Tony Helms requested, and one with ALL vehicles in the Sheriff's office. Commissioner Gohagan made a motion to recess at 11:52 A.M. and reconvene at 1:00 P.M.. Commissioner Williams seconded the motion. The motion passed by vote: Commissioner Gohagan (Yes) and Commissioner Williams (Yes). Commisisoner Gohagan made a motion to come back into session at 1:01

P.M. Commissioner Williams seconded the motion. The motion passed by vote: Commissioner Gohagan (Yes) and Commissioner Williams (Yes). Commissioner Gohagan made a motion to approve the recessed agenda. Commissioner Williams seconded the motion. The motion passed by vote: Commissioner Gohagan (Yes) and Commissioner Williams (Yes). Verizon was able to present three quotes to the commission as requested. Commissioner Gohagan made a motion to approve the quote that Sheriff Tony Helms originally requested- 53 vehicles in his department. Commissioner Williams seconded the motion. The motion passed by vote: Commissioner Gohagan (Yes) and Commissioner Williams (Yes). Commissioner Williams made a motion to exit regular session at 1:12 P.M. and Commissioner Gohagan seconded that motion. The motion passed by vote: Commissioner Williams (Yes) and Commissioner Gohagan (Yes).

Closed Session- RSMo 610.021 #1- Commissioner Williams made a motion to enter into an emergency closed session at 1:13 P.M. Commissioner Gohagan seconded the motion. The motion passed by vote: Commissioner Williams (Yes) and Commissioner Gohagan (Yes). Roll-call vote was taken: Commissioner Williams (Aye), Commissioner Gohagan (Aye) and Commissioner Skelton (Aye). At 1:52 P.M., Commissioner Gohagan made a motion to exit closed session. Commissioner Williams seconded the motion. The motion passed by vote: Commissioner Gohagan (Yes) and Commissioner Williams (Yes). Roll-call vote was taken: Commissioner Gohagan (Aye), Commissioner Williams (Aye), and Commissioner Skelton (Aye).

Adjourn: With no further official business on the agenda, Commissioner Gohagan made a motion to adjourn to any unofficial business that may develop during the day. Commissioner Williams seconded the motion. The motion passed by vote: Commissioner Gohagan (Yes) and Commissioner Williams (Yes). Session closed at 1:53 P.M.
