

COUNTY COMMISSION RECORD, CAMDEN COUNTY, MISSOURI

The Camden County Commission met with Presiding Commissioner Ike Skelton, First District Commissioner James Gohagan, and Second District Commissioner Don Williams.

Meeting Agenda

Commissioner Williams made a motion to approve today's agenda. Commissioner Gohagan seconded the motion. The motion passed by vote: Commissioner Williams (aye) and Commissioner Gohagan (aye). Session opened at 10:00 A.M.

Prior Minutes

There were no minutes present to be voted on.

New Business

Discuss Health Dept.'s Verizon Contract- It was brought to the attention of the Commission that this contract is actually with AT&T, not Verizon, by the Purchasing Agent the morning of this meeting. Currently, the Health Department is paying \$2,028.00 per month for their phone and internet service. A new contract was drafted that would save the Health Department \$1,281.00 per month making their monthly bill to AT&T only \$747.00. Jennifer Finley from the Health Department and Janet Fry in the Purchasing Department agreed that this new contract would meet the needs of the Health Department for phone and internet service and requested the Commission accept this new contract with AT&T that would be in effect for 36 months. Commissioner Williams made a motion to approve this contract with AT&T. Commissioner Gohagan seconded the motion. The motion passed by vote: Commissioner Williams (aye) and Commissioner Gohagan (aye).

Discuss SpyGlass Findings- Possible Savings Available for Internet Services-

Alexa from The SpyGlass Group, LLC contacted the county's Purchasing Department in regard to opportunities to save money within the Assessor's Office and the Admin. Building with Charter Spectrum. According to Alexa, the Assessor Real Estate building could save as much as \$9,012.00 annually during a 36-month contract, and the Administration building could save as much as \$3,960.00 annually during a 36-month contract. This is a combined annual savings of \$12,972.00. SpyGlass's conditions require the county pay the first year of annual savings (\$12,972) as payment for their services. The county then pockets the savings for the remaining years of the contract. Commissioner Williams made a motion to approve the suggestions of SpyGlass and issue them the funds of approximately \$12,972.00 according to contract for the savings that the county will see coming forward. Commissioner Gohagan seconded the motion. The motion passed by vote: Commissioner Williams (aye) and Commissioner Gohagan (aye).

Approval/Signing of Certified Copy of Order for Budget Amendments to County

Health-care Fund- Commissioner Gohagan made a motion to approve the signing of the Certified Copy of Order for the budget amendments pertaining to the County's health-care fund. Commissioner Williams seconded the motion. The motion passed by vote: Commissioner Gohagan (aye) and Commissioner Williams (aye).

March 2024 Tax Abatements- Commissioner Williams made a motion to approve the March 2024 tax abatements that were tentatively approved previously by an employee of the Commission Office. Commissioner Gohagan seconded the motion. The motion passed by vote: Commissioner Williams (aye) and Commissioner Gohagan (aye).

Adjourn: With no further official business on the agenda, Commissioner Williams made a motion to adjourn to any unofficial business that may develop during the day. Commissioner Gohagan seconded the motion. The motion passed by vote: Commissioner Williams (Yes) and Commissioner Gohagan (Yes). Session closed at 10:21 A.M.
