## **Meeting Agenda**

## **Prior Minutes**

Commissioner Williams made a motion to accept the March 29, 2023 minutes. Commissioner Gohagan seconded the motion. The motion passed by vote: Commissioner Williams (Yes) and Commissioner Gohagan (Yes).

## **New Business**

**Road Petitions-** There were four road petitions presented to the commission this day:

1. Big Cedar Subdivision- Starling Springs Road- This petition to vacate was presented to the commission by three supporting parties. There were no opposing parties in attendance. Commissioner Williams made a motion to approve the vacation. Commissioner Gohagan seconded the motion. The motion passed by vote: Commissioner Williams (Yes) and Commissioner Gohagan (Yes).

2. 665 Coelleda School Road- This petition to vacate this road was previously tabled until the petitioner could provide a more detailed legal description. That legal description was updated and resubmitted. There were no opposing or supporting parties in attendance. Commissioner Williams made a motion to approve the vacation. Commissioner Gohagan seconded the motion. The motion passed by vote: Commissioner Williams (Yes) and Commissioner Gohagan (Yes).
3. Murry Street- Block 17 & 18 in Climax Springs- This is the second time this petition has been presented to the commission to vacate Murry Street in Climax Springs; it was previously tabled. The petitioners, Barbara and Brantley Keltner were present. There was a question of the validity of the petition itself because it appears that each name on the petition is written in the same handwriting with no actual signatures of support. Commissioner Gohagan advised the Keltners and any other property owners this petition effects to sign in support or appear before the commission in opposition before the petition would be approved or denied. The Keltners requested the petition to vacate be tabled because all they wanted to know today is if the street is open or closed. Commissioner Williams made a motion to table the petition for vacation. Commissioner Gohagan seconded the motion. The motion passed by vote: Commissioner Williams (Yes) and Commissioner Gohagan (Yes).
4. End of Sellers Road (5-58)- Tract 1 of Scandia Subdivision- Request to vacate- The petitioners were present. They own the land that surrounds this peninsula. The County Attorney, Jeff Green, stated that there were no issues with this road vacation request. There were no opposing parties present. Commissioner Williams made a motion to approve the petition for vacation. Commissioner Gohagan seconded the motion. The motion passed by vote: Commissioner Williams (Yes) and Commissioner Gohagan (Yes).

**Adjourn:** With no further official business on the agenda, Commissioner Williams made a motion to adjourn to any unofficial business that may develop during the day. Commissioner Gohagan seconded the motion. The motion passed by vote: Commissioner Williams (Yes) and Commissioner Gohagan (Yes). Session closed at 10:36 A.M.
