

# COUNTY COMMISSION RECORD, CAMDEN COUNTY, MISSOURI

Tuesday 05/09/2023

The Camden County Commission met with Presiding Commissioner Ike Skelton, District #1 Commissioner James Gohagan, and District #2 Commissioner Don Williams.

## Meeting Agenda

Commissioner Williams made a motion to approve today's agenda. Commissioner Gohagan seconded the motion. The motion passed by vote: Commissioner Williams (Yes) and Commissioner Gohagan (Yes). Session opened at 10:00 A.M.

## Prior Minutes

Commissioner Williams made a motion to accept the May 3, 2023 and May 4, 2023 minutes. Commissioner Gohagan seconded the motion. The motion passed by vote: Commissioner Williams (Yes) and Commissioner Gohagan (Yes).

## New Business

**Dave Remerscheid-** Mr. Remerscheid was present to discuss an issue he ran into with receiving a real-estate tax bill. Commissioner Gohagan and Deputy Assessor, Byron Willis, discussed creating a presentation and inviting title companies in the county to meet and discuss the process that occurs in the assessor's office. There were no actions taken on this item.

**Surplus Properties- RFQ for Auction Services-** There are two pieces of property the county is ready to sell: a piece off of HH and North Hwy 5 in Camdenton. Commissioner Williams made a motion to direct the head of the purchasing department to put out an RFQ for auction services. Commissioner Gohagan seconded the motion. The motion passed by vote: Commissioner Williams (Yes) and Commissioner Gohagan (Yes).

**RFQ for Financial Audit-** Commissioner Williams made a motion to direct the head of the purchasing department to put out an RFQ for a new company to come in and perform the yearly financial audits for the county. Commissioner Gohagan seconded the motion. The motion passed by vote: Commissioner Williams (Yes) and Commissioner Gohagan (Yes).

**2023 Tax Sale Publication Bid Award-** Commissioner Williams made a motion to award the Lake Sun’s bid for publishing the 2023 Tax Sale based on the recommendation of the Camden County Collector. Commissioner Gohagan seconded the motion. The motion passed by vote: Commissioner Williams (Yes) and Commissioner Gohagan (Yes).

### **Other Business**

**Press Pass-** Commissioner Gohagan stated he believes Jordyn Wilson with Lake Sun should have a press pass when the meetings take place in the courthouse meeting room again.

**Adjourn:** With no further official business on the agenda, Commissioner Williams made a motion to adjourn to any unofficial business that may develop during the day. Commissioner Gohagan seconded the motion. The motion passed by vote: Commissioner Williams (Yes) and Commissioner Gohagan (Yes). Session closed at 10:38 A.M.
