The Camden County Commission met with Presiding Commissioner Greg Hasty, District #1 Commissioner James Gohagan, and District #2 Commissioner Don Williams.

## Meeting Agenda

After discussion, the Commission decided to postpone the appointment. Commissioner Williams made a motion to table the BOA appointment. Commissioner Gohagan seconded the motion. The motion passed by vote: Commissioner Williams (Yes) and Commissioner Gohagan (Yes).
