New Business

EMA Mask Bid Award – Commissioner Williams, at the recommendation of the EMA Director, made a motion to approve the mask bid award to Silverstone Fashion. They were the least expensive of the 8 bids received. Commissioner Hasty seconded the motion. The motion passed by vote: Commissioner Hasty (Yes), Commissioner Williams (Yes).



Commission

After much consideration and review, I request that you approve the bid on the 100,000 mask that we received from Silverstone Fashion Inc Ontario CA. I had taken one of the sample mask they provided to the Health Department and they agree that for the purpose we are using them they would work well. The bid from Silverstone is the lowest at \$0.14 per mask or a total of \$14,000, which includes all shipping cost. The next lowest bid was \$0.24 per mask, the highest bid received was \$0.49.

One concern I need to make you aware of is the bid requested that the mask be FDA and CE certified. The manufacture meets the FDA requirement however I cannot find where they are CE certified. CE stands for "Conformite Europeenne" which is French for "European Conformity". This simply means that the company or manufacture is claiming to be in compliance with the applicable European standards for products sold within the European Economic Area. My thought is if they meet our FDA requirements then we should not be concerned with the CE standard. I would appreciate your thoughts on this.
