Tax Levy – The County Clerk presented the Commission with the tax levy for 2021. He recommended no changes from the previous year. Commissioner Gohagan made a motion to accept the new tax levy. Commissioner Williams

seconded the motion. The motion passed by vote: Commissioner Williams (Yes) and Commissioner Gohagan (Yes).


