## New Business

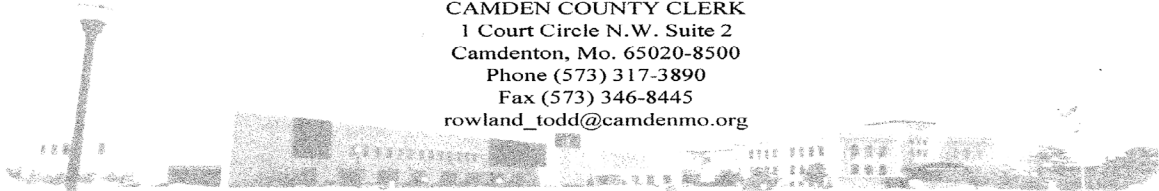
**Horseshoe Bend Special Road District – Cart Funds** – The Commission discussed and reviewed the 2021 Camden County CART receipts from the Dept. of Revenue. The Commission determined that the amount due HSBSRD was \$335,404.18. Commissioner Gohagan made a motion to order Kendra Hicks, Camden County Treasurer, to issue \$335,404.18 to HSBSRD for CART fund reimbursement. Commissioner Williams seconded the motion. The motion passed by vote: Commissioner Williams (Yes) and Commissioner Gohagan (Yes).

**Tax Levy** – The County Clerk presented the Commission with the tax levy for 2022. He recommended no changes from the previous year. Commissioner Gohagan made a motion to accept the new tax levy. Commissioner Williams

seconded the motion. The motion passed by vote: Commissioner Williams (Yes) and Commissioner Gohagan (Yes).

**Request for Surplus** – A request for surplus funds for a property sold in the 2020 Tax Sale was presented to the Commission by a citizen. After reviewing the request, Commissioner Gohagan made a motion to approve the request. Commissioner Williams seconded the motion. **Establish a Full Time County Attorney Position** – The Commission determined that a full time County Attorney would be necessary going forward. Commissioner Gohagan made a motion to create a full time County Attorney position effective 01/01/2023. Commissioner Williams seconded the motion. The motion passed by vote: Commissioner Williams (Yes) and Commissioner Gohagan (Yes).

**Jeffrey E. Green Contract** – The current part-time County Attorney will be retiring at the end of December 2022. Commissioner Williams made a motion to fill the full time County Attorney position effective 01/01/2023 with Jeffrey E. Green and sign an annual contract with him. Commissioner Gohagan seconded the motion. The motion passed by vote: Commissioner Williams (Yes) and Commissioner Gohagan (Yes).

**Adjourn:** With no further official business on the agenda: Commissioner Williams made a motion to adjourn to any unofficial business that may develop during the day. Commissioner Gohagan seconded the motion. The motion passed by vote: Commissioner Gohagan (Yes) and Commissioner Williams (Yes). Session closed at 10:26 A.M.
