Monday 10/02/2023

The Camden County Commission met with Presiding Commissioner Ike Skelton, First District Commissioner James Gohagan, and Second District Commissioner Don Williams.

Meeting Agenda

Commissioner Williams made a motion to approve today's agenda. Commissioner Gohagan seconded the motion. The motion passed by vote: Commissioner Williams (Yes) and Commissioner Gohagan (Yes). Session opened at 10:02 A.M.

Prior Minutes

Commissioner Gohagan made a motion to approve the meeting minutes from September 26, 2023. Commissioner Williams seconded the motion. The motion passed by vote: Commissioner Gohagan (yes) and Commissioner Williams (yes).

New Business

Road Petitions-

- a. Sioux Court Cul-de-Sac at Kay's Point- There were no parties present in favor or opposition of this matter. Camden County attorney notated his recommendation of approval. Commissioner Gohagan made a motion to approve the petition to vacate. Commissioner Williams seconded the motion. The motion passed by vote: Commissioner Gohagan (yes) and Commissioner Williams (yes).
- b. Lamplighter Drive- There were two parties present in favor- the applicants. There were no parties present in opposition of the matter. Commissioner Gohagan made a motion to approve the petition to vacate. Commissioner Williams seconded the motion. The motion passed by vote: Commissioner Gohagan (yes) and Commissioner Williams (yes). It was then discovered that the road petitions were not in order as listed on the agenda, and the

road petition that was voted on was not Lamplighter Drive. Commissioner Williams made a motion to resend the motion approving the petition to vacate. Commissioner Gohagan seconded the motion. The motion passed by vote: Commissioner Williams (yes) and Commissioner Gohagan (yes). The petition for Lamplighter Drive was found and County Attorney notated his recommendation to the Commission to deny this request until further documentation is received. Commissioner Williams made a motion to table this road petition. Commissioner Gohagan seconded the motion. The motion passed by vote: Commissioner Williams (yes) and Commissioner Gohagan (yes).

- c. Jean Road of Horseshoe Bend #7- There were no parties present in favor or opposition for this matter. County Attorney notated his recommendation of approval. Commissioner Gohagan made a motion to approve Jean Road road vacation. Commissioner Williams seconded the motion. The motion passed by vote: Commissioner Gohagan (yes) and Commissioner Williams (yes).
- d. Dolly Baker Subdivision- There was one party present in favor of the petition to vacate- the applicant. County Attorney notated recommendation to deny due to lack of signature of support from surrounding landowner. Commissioner Williams made a motion to table this petition to vacate. Commissioner Gohagan seconded the motion. The motion passed by vote: Commissioner Williams (yes) and Commissioner Gohagan (yes).
- e. Noland's Broadview Heights- There was one party present in favor, no parties present in opposition. County Attorney notated his recommendation for approval. Commissioner Gohagan made a motion to approve the petition to vacate. Commissioner Williams seconded the motion. The motion passed by vote: Commissioner Gohagan (yes) and Commissioner Williams (yes).
- f. Mimosa Road- This petition to vacate was tabled at the last Road Petition meeting in July of 2023. There were no parties present in favor or opposition. County Attorney notated his recommendation for approval. Commissioner Williams made a motion to approve the petition to vacate. Commissioner Gohagan seconded the motion. The motion passed by vote: Commissioner Williams (yes) and Commissioner Gohagan (yes).

County Enterprise Contract- Commissioner Williams made a motion to approve the contract with Enterprise Fleet Management. Commissioner Gohagan seconded the motion. The motion passed by vote: Commissioner Williams (yes) and Commissioner Gohagan (yes).

Adjourn: With no further official business on the agenda, Commissioner Williams made a motion to adjourn to any unofficial business that may develop during the day. Commissioner Gohagan seconded the motion. The motion passed by vote: Commissioner Williams (Yes) and Commissioner Gohagan (Yes). Session closed at 10:53 A.M.
