The Camden County Commission met with Presiding Commissioner Ike Skelton, First District Commissioner James Gohagan, and Second District Commissioner Don Williams.

## Meeting Agenda

Commissioner Gohagan made a motion to approve today's agenda. Commissioner Skelton seconded the motion. The motion passed by vote: Commissioner Gohagan (Yes) and Commissioner Skelton (Yes). Session opened at 9:00 A.M.

## New Business

**Prosecuting Attorney Budget Meeting** - There was discussion regarding items on their 2024 budget. Prosecuting Attorney Richelle Grosvenor asked to hire an additional. She asked for no increase to her budget. No motions were made on this agenda item.

**Bid Opening – NVRA- Clerk** – One bid was submitted for the Canvassing and Voter Registry Maintenance system to comply with the National Voter Registration Act (NVRA). This bid was from RICE Company. County Clerk Rowland Todd made the recommendation to accept this bid. Commissioner Williams made a motion to put the bid acceptance on the agenda to be voted on. **Purchasing Budget Meeting** – The Commission met with Purchasing Director. Discussion was held regarding a new postage machine. No motions were made on this agenda item.
