

# COUNTY COMMISSION RECORD, CAMDEN COUNTY, MISSOURI

Tuesday 10/19/2021

The Camden County Commission met with Presiding Commissioner Greg Hasty, District #1 Commissioner James Gohagan, and District #2 Commissioner Don Williams.

## Meeting Agenda

Commissioner Williams made a motion to approve today's agenda as posted. Commissioner Gohagan seconded the motion. The motion passed by vote: Commissioner Gohagan (Yes), Commissioner Williams (Yes). Session opened at 10:00 A.M.

## Prior Minutes

Commissioner Gohagan made a motion to approve the October 14, 2021 minutes. Commissioner Williams seconded the motion. The motion passed by vote: Commissioner Gohagan (Yes), Commissioner Williams (Yes).

## Public Comments

Time was set aside for comments from the public regarding agenda items. Several citizens used this opportunity to voice their opinions and concerns.

## New Business

**Road Vacation Orders** – Commissioner Gohagan made a motion to approve the Orders for the previously approved road vacations. Commissioner Williams seconded the motion. The motion passed by vote: Commissioner Gohagan (yes) and Commissioner Williams (yes).

**TCLA** – Commissioner Williams made a motion to select Tri-County Lodging Association as the designated DMO for Camden County. This would make TCLA eligible to receive grant funds from the Missouri Department of Tourism for a period of 5 years to promote tourism at The Lake of the Ozarks. Commissioner

Hasty seconded the motion. The motion passed by vote: Commissioner Gohagan (No), Commissioner Williams (Yes), and Commissioner Hasty (Yes). Commissioner Gohagan made a motion to deny TCLA as the designated DMO. The motion had no second.

**Parking Lot Lights** – A safety concern was brought to the Commission’s attention. Elected officials and employees addressed the need for better lighting in the County parking lot especially when employees are working late. A quote was received from Laclede Electric to place 3 poles and 4 additional lights at a cost of \$1500 to \$2000. This price is well below the need for a formal bid. Commissioner Gohagan made a motion to accept the quote from Laclede Electric. Commissioner Williams seconded the motion. The motion passed by vote: Commissioner Gohagan (Yes) and Commissioner Williams (Yes).

**Adjourn:** With no further official business on the agenda: Commissioner Williams made a motion to adjourn to any unofficial business that may develop during the day. Commissioner Gohagan seconded the motion. The motion passed by vote: Commissioner Gohagan (Yes), and Commissioner Williams (Yes). Session closed at 11:31 A.M.
