

## COUNTY COMMISSION RECORD, CAMDEN COUNTY, MISSOURI

Tuesday 11/29/2022

The Camden County Commission met with District #1 Commissioner James Gohagan and District #2 Commissioner Don Williams. Presiding Commissioner Greg Hasty was out of office. Camden County Clerk, Rowland Todd, appointed Commissioner Gohagan as Acting Presiding Commissioner as Commissioner Hasty was out of office.

### Meeting Agenda

Commissioner Williams made a motion to approve today's agenda. Commissioner Gohagan seconded the motion. The motion passed by vote: Commissioner Gohagan (Yes) and Commissioner Williams (Yes). Session opened at 10:00 A.M.

### Prior Minutes

Commissioner Williams made a motion to accept the minutes for November 17, 2022. Commissioner Gohagan seconded the motion. The motion passed by vote: Commissioner Gohagan (Yes) and Commissioner Williams (Yes).

### New Business

**Budget Hearing** – Camden County Auditor, Jimmy Laughlin, met with the Commission and other Elected Officials to discuss the preliminary 2023 Budget. The Auditor explained where the County revenues come from and how they are dispersed among the different departments.

**221129 Sheriff Bid Ram SSV** – One bid was received from Nroute LLC. At the recommendation of the Camden County Sheriff, Commissioner Williams made a motion to approve the bid for two 2022 Ram 1500 SSV Crew Cab 4WD for \$41,000 ea. Commissioner Gohagan seconded the motion. The motion passed by vote: Commissioner Williams (Yes) and Commissioner Gohagan (Yes).

**221129 E911 Sign Material Bid** - One bid was received from CPC Products. At the recommendation of the Camden County E911 Director, Commissioner Williams made a motion to approve the bid from CPC Products for sign materials. Commissioner Gohagan seconded the motion. The motion passed by vote: Commissioner Williams (Yes) and Commissioner Gohagan (Yes).

**221129 Office Flooring Bid** – No bids were received for the office flooring. Commissioner Williams made a motion to table the bid. Commissioner Gohagan seconded the motion. The motion passed by vote: Commissioner Williams (Yes) and Commissioner Gohagan (Yes).

**221129 Printing Bid** – One bid was received for the County printing. The bid was from Alphagraphics. At the recommendation of the Purchasing Director, Commissioner Williams made a motion to approve the bid from Alphagraphics. Commissioner Gohagan seconded the motion. The motion passed by vote: Commissioner Williams (Yes) and Commissioner Gohagan (Yes).

**Wastewater Printer** – A proposal for a new printer for the Wastewater office was presented to the Commission for review. Commissioner Williams made a motion to approve the purchase of the printer and the service contract. Commissioner Gohagan seconded the motion. The motion passed by vote: Commissioner Williams (Yes) and Commissioner Gohagan (Yes).

**Cocamo Ridge Development – Road Name Changes** – Three petitions for road renaming were presented to the Commission for their consideration. These roads are all in the Estates of Kinderhook development formerly known as Cocamo Ridge Development. Commissioner Williams made a motion to approve the name change of Cocamo Ridge Drive to Kingsman Drive. Commissioner Gohagan seconded the motion. The motion passed by vote: Commissioner Williams (Yes) and Commissioner Gohagan (Yes). Commissioner Williams made a motion to approve the name change of Lucille Lane to Big Cedar Drive. Commissioner Gohagan seconded the motion. The motion passed by vote: Commissioner Williams (Yes) and Commissioner Gohagan (Yes). Commissioner Williams made a motion to table the name change of Cocamo Ridge Lane as a suitable name has not yet been chosen. Commissioner Gohagan seconded the motion. The motion passed by vote: Commissioner Williams (Yes) and Commissioner Gohagan (Yes).

**Bid Approval – IT Storage Device** – A request for the purchase of a storage device was presented to the Commission. Commissioner Williams made a motion to

deny the purchase. Commissioner Gohagan seconded the motion. The motion passed by vote: Commissioner Williams (Yes) and Commissioner Gohagan (Yes).

**IT – Grant Application** – An application for an IT grant was considered by the Commission. Commissioner Williams made a motion to approve the grant application. Commissioner Gohagan seconded the motion. The motion passed by vote: Commissioner Williams (Yes) and Commissioner Gohagan (Yes).

**Adjourn:** With no further official business on the agenda: Commissioner Williams made a motion to adjourn to any unofficial business that may develop during the day. Commissioner Gohagan seconded the motion. The motion passed by vote: Commissioner Gohagan (Yes) and Commissioner Williams (Yes). Session closed at 11:04 A.M.
