

COUNTY COMMISSION RECORD, CAMDEN COUNTY, MISSOURI

Tuesday 12/13/2022

The Camden County Commission met with Presiding Commissioner Greg Hasty, District #1 Commissioner James Gohagan, and District #2 Commissioner Don Williams.

Meeting Agenda

Commissioner Williams made a motion to approve today's agenda. Commissioner Gohagan seconded the motion. The motion passed by vote: Commissioner Gohagan (Yes) and Commissioner Williams (Yes). Session opened at 10:00 A.M.

Prior Minutes

Commissioner Williams made a motion to approve the December 8, 2022 minutes. Commissioner Gohagan seconded the motion. The motion passed by vote: Commissioner Gohagan (Yes) and Commissioner Williams (Yes).

New Business

Lake of the Ozarks Multiplex – Letter of Support – The Commission was presented with a request from the Lake of the Ozarks Multiplex asking for a show of support as they pursue a Local Tourism Asset Development Grant from the Missouri Department of Economic Development. Commissioner Gohagan made a motion to approve the letter of support. Commissioner Williams seconded the motion. The motion passed by vote: Commissioner Williams (Yes) and Commissioner Gohagan (Yes).

Pecan Rd. Name Change – A request to rename Pecan Rd to Papa's Ranch Road was brought before the Commission. Commissioner Williams made a motion to approve the road name change and wave the fee. Commissioner Gohagan

seconded the motion. The motion passed by vote: Commissioner Gohagan (Yes) and Commissioner Williams (Yes).

November Abatements – Commissioner Gohagan made a motion to ratify the tax abatements for November tentatively approved previously by a commissioner. Commissioner Williams seconded the motion. The motion passed by vote: Commissioner Williams (Yes) and Commissioner Gohagan (Yes).

Collector/Assessor/Recorder Flooring Bid – One bid from Richardson’s Carpet was received for the flooring for the Collector, Assessor, and Recorder’s Offices. The cost of the flooring was not previously included with the building repairs. Commissioner Williams made a motion to table the bid so that it can be reviewed. Commissioner Gohagan seconded the motion. The motion passed by vote: Commissioner Gohagan (Yes) and Commissioner Williams (Yes).

Stop Loss Renewal – Mutual Medical presented a quote for the County’s stop loss renewal insurance. Two options were given. Commissioner Gohagan made a motion to table the renewal to allow time to review each option. Commissioner Williams seconded the motion. The motion passed by vote: Commissioner Williams (Yes) and Commissioner Gohagan (Yes).

Veregy – Representatives from Veregy were not able to attend. There was a brief discussion regarding the bid for the building repairs and delays.

Adjourn: With no further official business on the agenda, Commissioner Williams made a motion to adjourn to any unofficial business that may develop during the day. Commissioner Gohagan seconded the motion. The motion passed by vote: Commissioner Gohagan (Yes) and Commissioner Williams (Yes). Session closed at 11:20 A.M.
