The Camden County Commission met with Presiding Commissioner Greg Hasty, District #1 Commissioner Beverly Thomas, and District #2 Commissioner Don Williams.

**Meeting Agenda**

Commissioner Thomas made a motion to approve today's agenda as posted. Commissioner Williams seconded the motion. The motion passed by vote: Commissioner Williams (Yes) Commissioner Thomas (Yes). Session opened at 1:02 P.M.

**Prior Minutes**

**ROAD AMENDMENT-** Commissioner Thomas stated that her recommendation is to approve the Amended Road Amendment as it has been amended to remove that the amendment was advertised in the local paper, as it was not advertised in the local paper. **POLICY UPGRADING COUNTY ROADS-** Commissioner Thomas stated this is the resolution for the policy to upgrade county roads from gravel to pavement. Commissioner Williams made a motion to approve the Resolution to adopt the new Policy for upgrading county gravel roads to paved roads. Commissioner

**ROAD IMPACT FEES-** As the Road Amendment Policy was adopted today, the road impact fees for today will not require a vote so they are not presented.
