NOTICE IS HEREBY GIVEN TO THE LEGAL AND QUALIFIED VOTERS OF CAMDEN COUNTY, MISSOURI, THAT A PRIMARY ELECTION WILL BE HELD IN SAID COUNTY OF CAMDEN, STATE OF MISSOURI, ON THE 10<sup>TH</sup> DAY OF MARCH, 2020 FOR THE PURPOSES OF VOTING ON CANDIDATES CERTIFIED TO THIS OFFICE BY JOHN R. ASHCROFT, SECRETARY OF STATE, STATE OF MISSOURI. POLLING PLACES WILL BE OPEN BETWEEN THE HOURS OF 6 A.M. AND 7 P.M. DURING WHICH TIME ANY PERSON PROPERLY REGISTERED TO VOTE WILL BE GIVEN THE OPPORTUNITY TO PLACE HIS OR HER BALLOT. THE BALLOT FOR THE ELECTION SHALL BE IN SUBSTANTIALLY THE FOLLOWING FORM: **TO VOTE, DARKEN IN THE OVAL (S) COMPLETELY NEXT TO YOUR CHOICE, LIKE THIS,  IF YOU DEFACE, OR MAKE A MISTAKE OR MARK ANY BALLOT WRONG, YOU MUST RETURN IT TO THE ELECTION JUDGES AND RECEIVE A NEW BALLOT.**
